Arch Indemnity Insurance Company (“Arch Indemnity”) is a Nebraska domiciled property and casualty insurance company that has applied to the Director of Insurance of the State of Nebraska (“Director”) for approval to redomesticate from Nebraska to Missouri. After reviewing the filings, correspondence, and all pertinent information provided to the Nebraska Department of Insurance (“Department”), the Director hereby approves the application and finds, concludes, and orders as follows:

FINDINGS OF FACT

1. Arch Indemnity is a Nebraska domiciled property and casualty insurer that was initially licensed in the State of Nebraska on December 19, 1972.
2. Arch Indemnity filed an application to redomesticate from Nebraska to Missouri pursuant to Neb. Rev. Stat. §§ 44-161 to 44-164 (redomestication provisions) and the provisions of the Nebraska Business Corporation Act, Neb. Rev. Stat. §§ 21-2001 to 21-20,197.
3. The application for redomestication is subject to approval of the Director of the Nebraska Department of Insurance and the Missouri Department of Insurance.
4. Arch Indemnity has submitted all documents, information, and filings for the redomestication as required by Nebraska law and the Department.

5. On September 24, 2014, the Missouri Department of Insurance notified the Department that Arch Indemnity will be approved for redomestication to Missouri and be issued a certificate of authority by the Missouri Department of Insurance upon approval of the redomestication by the Department.

6. The Department has notified the Missouri Department of Insurance that it did not object to Arch Indemnity's redomestication to Missouri and has answered any questions the Missouri Department of Insurance had. Further, unresolved financial examination issues with the Department will be transmitted to the Missouri Department of Insurance for future resolution.

7. Arch Indemnity has provided the Department with copies of its Declaration of Intent to Redomesticate and Amended and Restated Articles of Incorporation to be filed with the Missouri Secretary of State.

8. As Arch Indemnity has filed all pertinent and required documents with the Department to support its application, the transfer of Arch Indemnity's domicile from Nebraska to Missouri should be approved.

#### CONCLUSIONS OF LAW

1. The State of Nebraska Department of Insurance has jurisdiction over the subject matter and the parties to this transaction.

2. The approval of this application will not in any manner impair the rights, remedies, or securities of Arch Indemnity's policyholders or creditors.

3. After redomestication, Arch Indemnity will meet all of the requirements for a Certificate of Authority as a foreign property and casualty insurer.

ORDER

IT IS THEREFORE ORDERED that the application of Arch Indemnity Insurance Company to transfer its domicile from Nebraska to Missouri is hereby approved.

The Nebraska Department of Insurance will issue Arch Indemnity Insurance Company a Certificate of Authority to do business as a foreign insurer in the State of Nebraska, effective as of the date of redomestication.
