In order to resolve this matter, the Nebraska Department of Insurance (“Petitioner”), by and through its attorney, Cheryl Wolff, and Jeremy Trautman (“Respondent”), (NAIC Producer #18037950), mutually stipulate and agree as follows:

JURISDICTION

1. Petitioner has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. §§ 44.101.01, and 44-4047 to 44-4067.
2. Respondent has been licensed as a non-resident insurance producer under the laws of Nebraska at all times material hereto.

STIPULATIONS OF FACT

1. Petitioner initiated this administrative proceeding by filing a Petition captioned State of Nebraska Department of Insurance vs. Jeremy Trautman (“Respondent”), (NAIC Producer #18037950), Cause Number A-2389 on June 20, 2024. A copy of the Petition was sent to the Respondent to his registered business, mailing, and residential address with the Nebraska Department of Insurance at 1625 Inglewood St., Forest Grove, OR 97116-3132, by certified mail, return receipt

requested, and by regular U.S. mail. Respondent acknowledges receiving proper Notice of these proceedings.

2. Respondent is alleged to have violated Neb. Rev. Stat. §§ 44-4059(1)(i) and (o) and 44-4065(1) as follows:

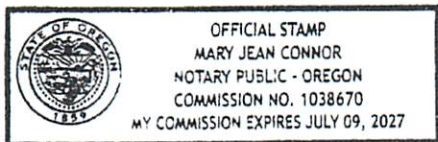
- a) On April 20, 2023, Respondent's resident license in Oregon, his state of domicile, was revoked for demonstrated lack of fitness or trustworthiness. This final order was not reported to the Department within 30 days.
- b) On November 17, 2023, Respondent's nonresident license in Utah was revoked for failure to report other state action and home state license revoked. This final order was not reported to the Department within 30 days.
- c) On December 12, 2023, Respondent's nonresident license in Indiana was suspended for failing to report the revocation of his resident license. This final order was not reported to the Department within 30 days.
- d) On January 18, 2024, Respondent's nonresident license in South Carolina was revoked for failure to report other state action. This final order was not reported to the Department within 30 days.
- e) Respondent does not hold a resident license in his home state of Oregon and does not intent to regain a resident insurance producers license.

3. Respondent admits the allegations in Paragraph 2.

4. Respondent was informed of his right to a public hearing. Respondent waives that right and enters into this Consent Order freely and voluntarily. Respondent understands and acknowledges that by waiving his right to a public hearing, Respondent also waives his right to confrontation of witnesses, production of evidence, and judicial review.


