In order to resolve this matter, the Nebraska Department of Insurance ("Department"), by and through its attorney, Scott A. Schroetlin, and Jeanne E. Rieks ("Respondent") mutually stipulate and agree as follows:

JURISDICTION

1. The Department has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. § 44-101.01 and the Insurance Producers Licensing Act, Neb. Rev. Stat. §§ 44-4047 to 4067.

2. Respondent was a licensed insurance producer under the laws of Nebraska at all times material hereto. Respondent's insurance producer license expires on May 31, 2016.

STIPULATIONS OF FACT

1. The Department initiated this administrative proceeding by filing a Petition and Notice of Hearing captioned *State of Nebraska Department of Insurance vs. Jeanne E. Rieks, NAIC National Producer #6887372*, Cause No. A-2017, on April 21, 2015.

2. The Department mailed a copy of the Petition and Notice of Hearing to the business address Respondent registered with the Department, Jeanne Rieks Agency, 524 Washington Ave, Iowa Falls, IA 50126, and to the home address Respondent registered with the

Department, 14434 Highway 65, Iowa Falls, IA 50126, by certified mail, return receipt requested. Respondent received a copy of the Petition and Notice of Hearing.

3. The Petition alleges that Respondent violated Neb. Rev. Stat. §§ 44-4055(1), 44-4059(1)(h) and 44-4059(1)(i) as follows:

a. On or about February 12, 2015, the Iowa Insurance Division issued an order revoking Respondent's insurance producer license for the state of Iowa, Respondent's state of residence.

4. Respondent was informed of her right to a public hearing. Respondent waives that right and enters into this Consent Order freely and voluntarily. Respondent understands and acknowledges that by waiving her right to a public hearing, Respondent also waives her right to confrontation of witnesses, production of evidence, and judicial review.

5. Respondent admits to the allegations alleged in paragraph 3. Respondent consents to the revocation of her Nebraska insurance producer license, #6887372.

CONCLUSIONS OF LAW

Respondent violated Neb. Rev. Stat. §§ 44-4055(1), 44-4059(1)(h) and 44-4059(1)(i) and is subject to disciplinary action pursuant to Neb. Rev. Stat. § 44-4059.

CONSENT ORDER

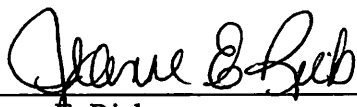

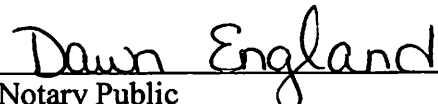

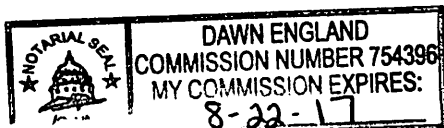
