Insurtech on the Silicon Prairie to Host Annual Conference on October 28 and 29

August 28, 2024 (LINCOLN, NE) – After breaking attendance records in 2023, Insurtech on the Silicon Prairie announces the conference will be back in Omaha, October 28 and 29. The daylong conference will be held at Omaha's Holland Performing Arts Center, and Insurtech on the Silicon Prairie will host a networking event at the Orpheum theater the prior evening.
