This matter came up for hearing on December 2, 2025, before Megan VanAusdall, a hearing officer duly appointed by the Director of the Nebraska Department of Insurance. At this hearing, the Nebraska Department of Insurance (“Department”) appeared through its counsel, Michael Anderson. Alyssa Gadson (“Respondent”) did not appear and was not represented by counsel. The proceedings were recorded by Shelly Storie, a licensed Notary Public. The Department offered Exhibits 1 and 2 at the hearing, which were received without objection. The Respondent did not offer any exhibits. After the conclusion of evidence, the matter was taken under advisement. The hearing officer makes the following Findings of Fact, Conclusions of Law, and Recommended Order.

FINDINGS OF FACT

1. The Department is the agency of the State of Nebraska charged with licensing insurance producers.
2. Respondent held a non-resident insurance producer license in this state, with a national producer number of 17837261. Respondent’s non-resident license expired on November 30, 2025. Respondent’s registered business and mailing address with the Nebraska Department of Insurance is 5601 POWERLINE RD, STE 309, FORT LAUDERDALE, FL 33309-2831, and Respondent’s residential address on file with the Department is 2763 NW 42nd AVE, COCOUNT CREEK, FL 33066-2108. Respondent’s registered personal email address is ALYCOACHES@GMAIL.COM. (Ex 1, Attachment 1)

3. On February 7, 2025, Petitioner's office, through employee Kevin Schlautman ("Schlautman"), head of the licensing division, received a NAIC Alert indicating that Delaware had revoked Respondent's insurance producer license. (Ex 1, Attachment 2)

4. A subsequent search of the RIRS database revealed that Respondent's resident license in her home state of Florida was revoked, effective March 6, 2025. (Ex 1, Attachment 3)

5. The search further found that Respondent had administrative actions taken against her in the states of Wisconsin, California, Indiana, Idaho, and Mississippi, as follows:

- a. Wisconsin- Effective May 30, 2023, Respondent's license was revoked for misrepresentation and late or incomplete response.
- b. California- Effective December 13, 2023, Respondent's license was revoked for other state administrative action.
- c. Indiana- Effective May 21, 2024, Respondent's license was denied for other state administrative action.
- d. Idaho- Effective April 28, 2025, Respondent's license was revoked for lack of fitness and trustworthiness.
- e. Mississippi- Effective June 9, 2025, Respondent's license was revoked for other state administrative actions.

(Ex 1, Attachment 4)

6. A review of Respondent's record showed that she did not provide the required notice to the Department of these administrative actions referenced above in the time period set under statute. (Ex 1)

7. On or about August 1, 2025, a Petition and Notice of Hearing were served upon Respondent by Shelly Storie, ("Ms. Storie"), an employee of the Petitioner's Office, by mailing the same to Respondent's registered addresses listed above, by certified mail, return receipt requested, and by regular U.S. mail. (Ex. 2)

8. On or about August 15, 2025, the Domestic Return Receipt card associated with the letter addressed to Respondent's registered business and mailing address in Fort Lauderdale, FL, was returned to the Petitioner's Office by the United States Postal Service ("USPS"), signed, confirming receipt. The letter sent by regular mail to the same address was not returned to the Department. As of December 2, 2025, the letters sent to Respondent's residential address, in

Coconut Creek, FL, via certified mail and regular mail have not been returned to the Petitioner's Office. (Ex. 2, Attachment 1)

9. On or about September 15, 2025, Ms. Storie served a Motion to Continue and Order Granting the Motion to Continue on the Respondent by sending a copy to both her registered addresses with the Department, by certified mail, return receipt requested, and by regular mail. On or about September 25, 2025, the Domestic Return Receipt Card sent to Respondent's mailing and business address in Fort Lauderdale, FL was returned by USPS signed, confirming receipt. As of December 2, 2025, the copy of the Motion to Continue and Order Granting Motion sent to Respondent's residential address, in Coconut Creek, FL, via regular mail has not been returned to the Petitioner's Office. (Ex. 2, Attachment 2)

10. On or about October 14, 2025, the Domestic Return Receipt card associated with the Motion to Continue and Order Granting Motion, addressed to Respondent's registered residential address in Coconut Creek, FL, was returned by the USPS marked "RETURN TO SENDER, UNCLAIMED, UNABLE TO FORWARD." As of December 2, 2025, the Motion and Order sent to the same address have not been returned to the Department. (Ex. 2, Attachment 3)

11. On or about October 21, 2025, Ms. Storie served a second Motion to Continue and Order Granting the Second Motion on Respondent, by sending copies of these addressed to both of Respondent's addresses on file, via certified mail, return receipt requested, and by regular mail. As of December 2, 2025, nothing from either mailing method or address has been received by the Department. (Ex. 2)

12. Upon checking the USPS tracking history for the service of the second Motion to Continue to and Order Granting Motion to Continue sent to 2763 NW 42nd Ave. Coconut Creek, Florida 33066, Ms. Storie found the following was logged: "Delivered, Left with Individual, POMPANO BEACH, FL 33066, October 24, 2025, 5:12 pm". The USPS Tracking history includes the subdivision maps for Coconut Creek and Pompano Beach Florida, showing that due to their proximity, Pompano Beach is a part of Coconut Creek. (Ex. 2, Attachment 4)

13. Upon checking the USPS tracking history for the service of the second Motion to Continue to and Order Granting Motion to Continue sent to 5601 Powerline Rd., STE 309, Fort Lauderdale, FL 33309, Ms. Storie found the following stated: "Delivered, Left with Individual, Fort Lauderdale, FL 33309, October 27, 2025, 3:06 pm." (Ex. 2, Attachment 5)

CONCLUSIONS OF LAW

1. The Department has broad jurisdiction, control, and discretion over the licensing of insurance producers in the State of Nebraska pursuant to Neb. Rev. Stat. §§ 44-101.01 and 44-4047 et seq.

2. The Department has personal jurisdiction over Respondent.

3. Pursuant to Neb. Rev. Stat. § 44-4059 (1), the Director of Insurance may suspend, revoke or refuse to issue or renew an insurance producer's license or may levy an administrative fine . . . for any one or more of the following causes: . . . (b) violating any insurance law or violating any rule, regulation, subpoena, or order of the director or of another state's insurance commissioner or director, . . . (i) having an insurance producer's license or its equivalent denied, suspended, or revoked in Nebraska or in any other state, province, district, or territory . . . and (o) failing to maintain in good standing a resident license in the insurance producer's home state.

4. Pursuant to Neb. Rev. Stat. § 44-4065(1), "An insurance producer shall report to the director any administrative action taken against the producer in another jurisdiction . . . within thirty days of the final disposition of the matter."

5. Respondent violated Neb. Rev. Stat. §§ 44-4059(1)(b), (i) & (o), as well as 44-4065(1), as a result of the conduct set forth in the Findings of Fact.

DISCUSSION

At the hearing, the Petitioner's Office presented sufficient evidence of proper service of notice of these proceedings upon Respondent, by serving Respondent via certified mail, return receipt requested and regular U.S. mail to the Respondent's registered addresses. The Department also provided a Domestic Return Receipt for the notice filings, which confirmed delivery to the Respondent. Based upon the evidence of record, the Department's service of the petition and notice of hearing upon Respondent at his business, residential, and mailing addresses of record were sufficient and jurisdiction over the actions of the Respondent in this matter has been established.

The uncontested evidence shows that Respondent violated the insurance code, pursuant to 44-4065(1) by her failure to inform the Department of the administrative actions in other states which she was named in, by having a license denied, suspended or revoked in another state, and by failing to maintain her insurance license in her resident state of Florida.

These actions constitute a violation of Neb. Rev. Stat. §§ 44-4059(1)(b), (i), & (o), and 44-4065(1).

RECOMMENDED ORDER

Based on the Findings of Fact and Conclusions of Law, it is recommended that Respondent's Nebraska non-resident insurance producer license be revoked. The Nebraska Department of Insurance shall retain jurisdiction of this matter for the purpose of enabling Respondent or the Department of Insurance to make application for such further orders as may be necessary.


