This matter came up for hearing on May 12, 2026, before Megan VanAusdall, a hearing officer duly appointed by the Director of the Nebraska Department of Insurance. The Nebraska Department of Insurance (“Department”) was represented by its counsel, Michael W. Anderson. Tamika Shannon, (“Respondent”) did not appear and was not represented by counsel. The proceedings were recorded by Shelly Storie, a licensed Notary Public. The Department offered Exhibits 1 and 2 at the hearing, which were received without objection. The Respondent did not offer any exhibits. After the conclusion of evidence, the matter was taken under advisement. The hearing officer makes the following Findings of Fact, Conclusions of Law, and Recommended Order.

FINDINGS OF FACT

1. The Department is the agency of the State of Nebraska charged with licensing insurance producers.
2. Tamika Shannon, (“Respondent”), is a resident insurance producer in this state, under a National Producer Number (“NPN”) of 21753471. Respondent’s license has a first active date of October 9, 2025, and an expiration date of July 31, 2026. Respondent’s only residential, mailing and business address on file with the Department is Nebraska Department of Insurance is 2115 N SHERIDAN AVE, GRAND ISLAND, Nebraska 68803, and her registered business and personal email address on file is TamikaShannon1984@outlook.es. (Ex. 1, Attachment 1)

3. On or about October 9, 2025, the Respondent, Shannon, submitted an application to the Department for a resident insurance producer's license. In her Application, Respondent marked "No" to Background Questions 1a and 1b, which ask if the applicant has any past or current misdemeanor or felony charges or convictions. (Ex. 1, Attachment 2)

4. On or about December 2, 2025, the administrator of the licensing division, Kevin Schlautman ("Schlautman"), conducted a case search of the Nebraska Judicial Branch's statewide trial case management system, known as "JUSTICE," (Judicial User System to Increase Court Effectiveness), an official website of the Nebraska government, which provides access to civil, criminal, traffic, juvenile and probate cases filed in all of this state's county and district courts. The search found records showing the following criminal conviction for Respondent:

- a. "Theft-shoplifting," a Class II misdemeanor out of Douglas County, Nebraska; Respondent pled guilty to this charge on November 25, 2002. (Ex. 1, Attachment 3)

5. On or about December 2, 2025, Schlautman sent a letter by certified mail, return receipt requested, addressed to Respondent's address on file, requesting a written statement from her regarding the conviction. (Ex. 1, Attachment 4)

6. On or about January 15, 2026, having not received a reply to his prior letter, Schlautman sent an email to Respondent's email address of record, informing Respondent that the previous letter sent December 2, 2026, had been returned to the Department as 'unclaimed.' Schlautman's email message to Respondent repeated his request for a written statement as well as an explanation of Respondent's non-disclosure of prior convictions. (Ex. 1, Attachment 5)

7. As of March 12, 2026, the Respondent has not submitted a written statement to the Department as requested and has failed to provide a copy of the relevant legal documents for her prior criminal conviction. (Ex. 1)

8. On or about March 11, 2026, Shelly Storie ("Storie"), an employee of the Department's Legal Division, served a copy the Petition and Notice of Hearing upon Respondent by mailing the same to Respondent's registered business, mailing and residential address, at 2115 N SHERIDAN AVE, GRAND ISLAND, Nebraska 68803, by certified mail, return receipt requested, via regular mail, and by sending a digital copy as an attachment to an email addressed to Respondent's email address on file, TamikaShannon1984@outlook.es. (Ex. 2)

9. On or about April 8, 2026, the letter and associated certified mail return receipt sent to Respondent’s address at 2115 N SHERIDAN AVE, was returned by USPS marked “RETURN TO SENDER, UNCLAIMED, UNABLE TO FORWARD.” (Ex. 2, Attachment 1)

a. As of June 8, 2026, the letter sent regular U.S. mail has not been returned to the Department.

10. As of June 8, 2026, Respondent has not provided any response to the Department regarding requests for more information or for her hearing. (Ex. 2)

CONCLUSIONS OF LAW

1. The Department has broad jurisdiction, control, and discretion over the licensing of insurance producers and licensed insurance agencies in the State of Nebraska pursuant to Neb. Rev. Stat. §§ 44-101.01 and 44-4047 to 40-4069.

2. The Department has personal jurisdiction over Respondent.

3. Pursuant to Neb. Rev. Stat. §44-4059(1), the director may suspend, revoke, or refuse to issue or renew an insurance producer's license or may levy an administrative fine if it is found that the producer has violated any insurance law.

4. Respondent violated Neb. Rev. Stat. §44-4059(1)(b) as a result of the conduct found in paragraphs 1-12 of the Findings of Fact and as evidenced by the relevant exhibits received.

5. Respondent violated Neb. Rev. Stat. §44-4059(1)(f) as a result of the conduct found in paragraphs 1-12 of the Findings of Fact and as evidenced by the relevant exhibits received.

DISCUSSION

At the hearing, the Department presented sufficient evidence of proper service of notice of these proceedings upon Respondent. The Department served Respondent via certified mail, return receipt requested and regular U.S. mail to the Respondent’s registered address. The Department also provided a Domestic Return Receipt for the notice filings, which provided confirmation of a reasonable attempt to contact Respondent. Based upon the evidence of record, the Department’s service of the petition and notice of hearing upon Respondent at her business, residential, and mailing addresses of record were sufficient and jurisdiction over the actions of the Respondent in this matter has been established.

The uncontested evidence shows that Respondent failed to disclose her prior criminal convictions on her Application for an insurance producers license in this state, and then, after Respondent received an inquiry letter from the Department, failed to provide a response to the Department.

These actions constitute a violation of Neb. Rev. Stat. § 44-4059(1)(b) and (f).

RECOMMENDED ORDER

Based on the Findings of Fact and Conclusions of Law, it is recommended that Respondent's resident insurance producer's license be revoked. The Nebraska Department of Insurance shall retain jurisdiction of this matter for the purpose of enabling Respondent or the Department of Insurance to make application for such orders as may be necessary.
