Insurtech on the Silicon Prairie Conference set to kick off this October

Lincoln, NE (Oct. 15, 2024) – After a record breaking attendance last year, Insurtech on the Silicon Prairie is anticipating another great conference in Omaha on October 28 and 29. The day-long conference will take place at the Holland Performing Arts Center, with a networking event scheduled the evening prior at the Orpheum Theater.

This national conference brings together industry leaders, innovators, startups, regulators, and more for a unique experience. Last year, Insurtech on the Silicon Prairie welcomed attendees from 44 states, along with international participants from across the globe.
