On or about December 20, 2018, Crop Pro Insurance Services, Inc., (NAIC National Producer #18491323) and GuideOne Mutual Insurance Company (NAIC #15032) (collectively referred to as “Respondents”) entered into a consent order to resolve an administrative action filed by the Nebraska Department of Insurance, State of Nebraska Department of Insurance v. Crop Pro Insurance Services, Inc. (“Crop Pro”) and GuideOne Mutual Insurance Company, A-2165 (“Consent Order”). Par. 3 of the Consent Order provides that it “extends to any successor entities of Crop Pro.” A copy of this consent order is attached hereto as Attachment 1.

On or about February 5, 2019, Crop Pro advised the Nebraska Department of Insurance (“Department”) that Crop Pro had changed its name to Growers Edge Financial, Inc. (“GEFI”) and redomiciled from Wyoming to Delaware, effective November 26, 2018. Crop Pro hereby certifies to the Department that this name change was not brought to the Department’s attention prior to execution of the Consent Order as a result of inadvertence, and that the Consent Order extends to and includes GEFI.

GEFI and the Department mutually agree to amend the prior consent order such that all references in the order to Crop Pro Insurance Services, Inc. are amended to Growers Edge Financial, Inc. (formerly known as Crop Pro Insurance Services, Inc.).


