001. Purpose

The purpose of this regulation is to provide for the reasonable standardization of coverage and simplification of terms and benefits of Medicare supplement policies; to facilitate public understanding and comparison of such policies; to eliminate provisions contained in such policies which may be misleading or confusing in connection with the purchase of such policies or with the settlement of claims; and to provide for full disclosures in the sale of sickness and accident insurance coverages to persons eligible for Medicare.

002. Authority

This regulation is issued pursuant to the authority vested in the Director <u>Neb.Rev.Stat</u>. §§44-3601 through 44-3610.

003. Applicability and Scope

- <u>003.01</u> Except as otherwise specifically provided in Sections 7, 15, 16, 19 and 24, this regulation shall apply to:
 - <u>003.01A</u> All Medicare supplement policies delivered or issued for delivery in this State on or after the effective date hereof, and
 - <u>003.01B</u> All certificates issued under group Medicare supplement policies, which certificates have been delivered or issued for delivery in this State.
- 003.02 This regulation shall not apply to a policy or contract of one or more employers or labor organizations, or of the trustees of a fund established by one or more employers or labor organizations, or combination thereof, for employees or former employees, or a combination thereof, or for members or former members, or a combination thereof, of the labor organizations.

004. Definitions

005. Policy definitions and terms

No policy or certificate may be advertised, solicited or issued for delivery in this State as a Medicare supplement policy or certificate unless such policy or certificate contains definitions or terms which conform to the requirements of this section.

No policy or certificate may be advertised, solicited or issued in this state as a Medicare supplement policy or certificate unless it meets or exceeds the following minimum standards. These are minimum standards and do not preclude the inclusion of other provisions or benefits which are not inconsistent with these standards.

The following standards are applicable to all Medicare supplement policies or certificates delivered or issued for delivery in this State on or after June 1, 1992 with an effective date for coverage and prior to June 1, 2010. No policy or certificate may be advertised, solicited, delivered or issued for delivery in this State as a Medicare supplement policy or certificate unless it complies with these benefit standards.

<u>008.01</u> General standards. The following standards apply to Medicare supplement policies and certificates and are in addition to all other requirements of this regulation.

Receipt of Medicare Part D benefits will not be considered in determining a continuous loss.

The following standards are applicable to al Medicare supplement policies or certificates delivered or issued for delivery in this state with an effective date for coverage on or after June 1, 2010. No policy or certificate may be advertised, solicited, delivered, or issued for delivery in this state as a Medicare supplement policy or certificate unless in complies with these benefit standards. No issuer may offer any 1990 Standardized Medicare supplement benefit plan for sale on or after June 1, 2010. Benefit standards applicable to Medicare supplement policies and certificates issued with an effective date for coverage prior to June 1, 2010 remain subject to the requirements of this regulation as it existed before June 1, 2010.

- <u>009.01</u> General Standards. The following standards apply to Medicare supplement policies and certificates and are in addition to all other requirements of this regulation.
 - <u>009.01A</u> A Medicare supplement policy or certificate shall not exclude or limit benefits for losses incurred more than six (6) months from the effective date of coverage because it involved a preexisting condition. The policy or certificate may not define a preexisting condition more restrictively than a condition for which medical advice was given or treatment was recommended by or received from a physician within six (6) months before the effective date of coverage.
 - <u>009.01B</u> A Medicare supplement policy or certificate shall not indemnify against losses resulting from sickness on a different basis than losses resulting from accidents.
 - <u>009.01C</u> A Medicare supplement policy or certificate shall provide that benefits designed to cover cost sharing amounts under Medicare will

be changed automatically to coincide with any changes in the applicable Medicare deductible, copayment, or coinsurance amounts. Premiums may be modified to correspond with such changes.

- <u>009.01D</u> No Medicare supplement policy or certificate shall provide for termination of coverage of a spouse solely because of the occurrence of an event specified for termination of coverage of the insured, other than the nonpayment of premium.

- <u>011.05H</u> Standardized Medicare supplement Plan K is mandated by The Medicare Prescription Drug, Improvement and Modernization Act of 2003, and shall include only the following:
 - <u>011.05H(1)</u> Part A Hospital Coinsurance 61st through the 90th days: Coverage of one hundred percent (100%) of the Part A hospital coinsurance amount for each day used from the 61st through the 90th day in any Medicare benefit period;

- <u>011.05H(2)</u> Part A Hospital Coinsurance, 91st through 150th days: Coverage of one hundred percent (100%) of the Part A hospital coinsurance amount for each Medicare lifetime inpatient reserve day used from the 91st through the 150th day in any Medicare benefit period;

018. Permitted Compensation Arrangements

<u>018.01</u> An insurer or other entity may provide commission or other compensation to an agent or other representative for the sale of a Medicare supplement policy or certificate only if the first year commission or other first year compensation is no more than 200 percent (200%) of the commission or other compensation paid for selling or servicing the policy or certificate in the second year or period.

<u>018.02</u> The commission or other compensation provided in subsequent (renewal) years must be the same as that provided in the second year or period and must be provided for no fewer than five renewal years.

018.03 No issuer or other entity shall provide compensation to its agents or other producers and no agent or producer shall receive compensation greater than the renewal compensation payable by the replacing insurer on renewal policies or certificates if an existing policy or certificate is replaced.

018.04 For purposes of this section, "compensation" includes pecuniary or non-pecuniary remuneration of any kind relating to the sale or renewal of the policy or certificate including, but not limited to, bonuses, gifts, prizes, awards and finders fees.

019. Required Disclosure Provisions

019.01 General Rules

<u>019.01A</u> Medicare supplement policies and certificates shall include a renewal, or continuation provision. The language or specifications of such provision shall be consistent with the type of contract issued. Such provision shall be appropriately captioned, and shall appear on the first page of the policy, and shall include any reservation by the issuer of the right to change premiums and any automatic renewal premium increases based on the policyholder's age.

019.01B Except for riders or endorsements by which the issuer effectuates a request made in writing by the insured, exercises a specifically reserved right under a Medicare supplement policy, or is required to reduce or eliminate benefits to avoid duplication of Medicare benefits, all riders or endorsements added to a Medicare supplement policy after date of issue or at reinstatement or renewal which reduce or eliminate benefits or coverage in the policy shall require a signed acceptance by the insured. After the date of policy or certificate issue, any rider or endorsement which increases benefits or coverage with a concomitant increase in premium during the policy term shall be agreed to in writing signed by the insured, unless the benefits are required by the minimum standards for Medicare supplement insurance policies, or if the increased benefits or coverage is required by law. Where a separate additional premium is charged for benefits provided in connection with riders or endorsements, such premium charge shall be set forth in the policy.

- <u>019.01C</u> Medicare supplement policies or certificates shall not provide for the payment of benefits based on standards described as "usual and customary," "reasonable and customary," or words of similar import.
- <u>019.01D</u> If a Medicare supplement policy or certificate contains any limitations with respect to preexisting conditions, such limitations must appear as a separate paragraph of the policy and be labeled as "Preexisting Condition Limitations."
- <u>019.01E</u> Medicare supplement policies and certificates shall have a notice prominently printed on the first page of the policy or certificate or attached thereto stating in substance that the policyholder or certificateholder shall have the right to return the policy or certificate within thirty (30) days of its delivery and to have the premium refunded if, after examination of the policy or certificate, the insured person is not satisfied for any reason.

Such notice shall be in no less than twelve (12) point type and shall contain the following language:

> "THIS [POLICY OR CERTIFICATE] IS NOT A MEDICARE SUPPLEMENT [POLICY OR CONTRACT]. If you are eligible for Medicare, review the Guide to Health Insurance for People with Medicare available from the company."

<u>019.05B</u> Applications provided to persons eligible for Medicare for the health insurance policies or certificates described in 019.04A shall disclose, using the applicable statement in Appendix C, the extent to which the policy duplicates Medicare. The disclosure statement shall be provided as a part of, or together with, the application for the policy or certificate.

A direct response insurer shall, at the time of the issuance of the policy or certificate, provide written notice of the senior insurance counseling program and the program's name, address and telephone numbers.

<u>022.03</u>	The terms "Medicare Supplement," "Medigap," "Medicare Wrap Around," and words of similar import shall not be used unless the policy is issued in compliance with this regulation.
023. Appropriateness of	of Recommended Purchase and Excessive Insurance
- <u>023.01</u>	In recommending the purchase or replacement of any Medicare supplement policy or certificate an agent shall make reasonable efforts to determine the appropriateness of a recommended purchase or replacement.
<u>023.02</u>	Any sale of a Medicare supplement policy or certificate that will provide an individual more than one Medicare supplement policy or certificate is prohibited.
<u>023.03</u>	An issuer shall not issue a Medicare supplement policy or certificate to an individual enrolled in Medicare Part C unless the effective date of the coverage is after the termination date of the individual's Part C coverage.
- 024. Reporting of Mul	tiple Policies
	On or before March 1 of each year, an issuer shall report the following information for every individual resident of this State for which the issuer has in force more than one Medicare supplement insurance policy or certificate:
<u>024.01</u>	<u>A</u> Policy and certificate number, and
<u>024.01</u>]	<u>B</u> Date of issuance.

- <u>-024.02</u> The items set forth above must be grouped by individual policyholder.
- <u>025.</u> <u>Prohibition Against Preexisting Conditions, Waiting Periods, Elimination Periods and</u> <u>Probationary Periods in Replacement Policies or Certificates</u>
 - <u>025.01</u> If a Medicare supplement policy or certificate replaces another Medicare supplement policy or certificate, the replacing issuer shall waive any time periods applicable to preexisting conditions, waiting periods, elimination periods and probationary periods in the new Medicare supplement policy or certificate to the extent such time was spent under the original policy.
 - <u>025.02</u> If a Medicare supplement policy or certificate replaces another Medicare supplement policy or certificate which has been in effect for at least six (6) months, the replacing policy shall not provide any time period applicable to preexisting conditions, waiting periods, elimination periods and probationary periods.

026. Prohibition Against Use of Genetic Information and Requests for Genetic Testing

This Section applies to all policies with policy years beginning on or after May 21, 2009.

<u>026.01</u> An issuer of a Medicare supplement policy or certificate:

- <u>026.01A</u> shall not deny or condition the issuance or effectiveness of the policy or certificate, including the imposition of any exclusion of benefits under the policy based on a pre-existing condition, on the basis of the genetic information with respect to such individual; and
- <u>026.01B</u> shall not discriminate in the pricing of the policy or certificate, including the adjustment of premium rates, of an individual on the basis of the genetic information with respect to such individual.
- <u>026.02</u> Nothing in Subsection 026.01 shall be construed to limit the ability of an issuer, to the extent otherwise permitted by law, from
 - <u>026.02A</u> Denying or conditioning the issuance or effectiveness of the policy or certificate or increasing the premium for a group based on the manifestation of a disease or disorder of an insured or applicant; or
 - <u>026.02B</u> Increasing the premium for any policy issued to an individual based on the manifestation of a disease or disorder of an individual who is covered under the policy, in such case, the disease or disorder in one individual cannot also be used as genetic information about other group members and to further increase the premium for the group.

- <u>026.03</u> An issuer of a Medicare supplement policy or certificate shall not request or require an individual or a family member of such individual to undergo a genetic test.
- <u>026.04</u> Subsection 026.03 shall not be construed to preclude an issuer of a Medicare supplement policy or certificate from obtaining and using the results of a genetic test in making a determination regarding payment, as defined for the purposes of applying the regulations promulgated under part C of title XI and section 264 of the Health Insurance Portability and Accountability Act of 1996, as may be revised from time to time, and consistent with Subsection 026.01.
- <u>026.05</u> For purposes of carrying out Subsection 026.04, an issuer of a Medicare supplement policy or certificate may request only the minimum amount of information necessary to accomplish the intended purpose.
- <u>026.06</u> Notwithstanding Subsection 026.03, an issuer of Medicare supplement policy may request, but not require, that an individual or a family member of such individual undergo a genetic test if each of the following conditions is met:
 - <u>026.06A</u> The request is made pursuant to research that complies with part 46 of title 45, Code of Federal Regulations, or equivalent Federal regulations, and any applicable State or local law or regulations for the protection of human subjects in research.
 - <u>026.06B</u> The issuer clearly indicates to each individual, or in the case of a minor child, to the legal guardian of such child, to whom the request is made that
 - <u>026.06B(1)</u> compliance with the request is voluntary; and
 - <u>026.06B(2)</u> non-compliance will have no effect on enrollment status or premium or contribution amounts.
 - <u>026.06C</u> No genetic information collected or acquired under this Subsection shall be used for underwriting, determination of eligibility to enroll or maintain enrollment status, premium rates, or the issuance, renewal, or replacement of a policy or certificate.
 - <u>026.06D</u> The issuer notifies the Secretary in writing that the issuer is conducting activities pursuant to the exception provided for under this Subsection, including a description of the activities conducted.
 - <u>026.06E</u> The issuer complies with such other conditions as the Secretary may by regulation require for activities conducted under this Subsection.

- <u>026.07</u> An issuer of a Medicare supplement policy or certificate shall not request, require, or purchase genetic information for underwriting purposes.
- <u>026.08</u> An issuer of a Medicare supplement policy or certificate shall not request, require, or purchase genetic information with respect to any individual prior to such individual's enrollment under the policy in connection with such enrollment.
- <u>026.09</u> In an issuer of a Medicare supplement policy or certificate obtains genetic information incidental to the requesting, requiring, or purchasing of other information concerning any individual, such request, requirement, or purchase shall not be considered a violation of Subsection 026.09 if such request, requirement, or purchase is not in violations of Subsection 026.08.
- <u>026.10</u> For the purposes of this Section only:
 - <u>026.10A</u> "Issuer of a Medicare supplement policy or certificate" includes third-party administrator, or other person acting for or on behalf of such issuer.
 - <u>026.10B</u> "Family member" means, with respect to an individual, any other individual who is a first degree, second degree, third degree, or fourth degree relative of such individual.
 - 026.10.C "Genetic information" means, with respect to any individual, information about such individual's genetic tests, the genetic tests of family members of such individual, and the manifestation of a disease or disorder in family members of such individual. Such term includes, with respect to any individual, and request for, or receipt of, genetic services, or participation in clinical research which includes genetic services, by such individual or any family member of such individual. Any reference to genetic information concerning an individual or family member of any individual who is a pregnant woman, includes genetic information of any fetus carried by such pregnant woman, or with respect to an individual or family member utilizing reproductive technology, includes genetic information of any embryo legally held by an individual or family member. The term "genetic information" does not include information about the sex or age of any individual.
 - <u>026.10D</u> "Genetic services" means a genetic test, genetic counseling (including obtaining, interpreting, or assessing genetic information:, or genetic education.

<u>026.10E</u> "Genetic test" means an analysis of human DNA, RNA, chromosomes, proteins, or metabolites, that detect genotypes, mutations, or chromosomal changes. The term "genetic test" does not mean an analysis of proteins or metabolites that does not detect genotypes, mutations, or chromosomal changes; or analysis of proteins or metabolites that is directly related to a manifested disease, disorder, or pathological condition that could reasonably be detected by a health care profession with appropriate training and expertise in the field of medicine involved.

<u>026.10F</u> "Underwriting purposes" means,

- <u>026.10F(1)</u> rules for, or determination of, eligibility (including enrollment and continued eligibility) for benefits under the policy;
- <u>026.10F(2)</u> the computation of premium or contribution amounts under the policy;
- <u>026.10F(3)</u> the application of any pre-existing condition exclusion under the policy; and
- <u>026.10F(4)</u> other activities related to the creation, renewal, or replacement of a contract of health insurance or health benefits.

027. Policy or Certificate Delivery Receipt

When a policy or certificate is delivered by an agent, a receipt of delivery of the policy or certificate, shall be signed by the agent and applicant, at the time of delivery of the policy, if hand delivered. A copy of the delivery receipt shall be provided to the applicant and a copy retained by the agent.

028. Separability

If any provision of this regulation or the application thereof to any person or circumstance is for any reason held to be invalid, the remainder of the regulation and the application of such provision to other persons or circumstances shall not be affected thereby.

029. Effective Date

Medicare Supplement carriers must comply with all parts of this revised regulation no later than June 1, 2010; with the exception of Section 26, which shall apply to all policies with policy years beginning on or after May 21, 2009.

APPENDIX C

DISCLOSURE STATEMENTS

Instructions for Use of the Disclosure Statements for Health Insurance Policies Sold to Medicare Beneficiaries that Duplicate Medicare

- 1. Section 1882(d) of the federal Social Security Act [42 U.S.C. 1395ss] prohibits the sale of a health insurance policy (the term policy or policies includes certificates) that duplicate Medicare benefits unless it will pay benefits without regard to other health coverage and it includes the prescribed disclosure statement on or together with the application.

The Department of Insurance (Department) hereby adopts the National Association of Insurance Commissioners (NAIC) model regulation, titled "Model Regulation to Implement the NAIC Medicare Supplement Insurance Minimum Standards Model Act" (hereinafter "model"), adopted by the NAIC on August 29, 2016 (as published in the 1st quarter of 2018 by the NAIC Model Regulation Service) and as recognized in the Federal Register on September 1, 2017 with the following notes, exceptions and additions:

02. This regulation is adopted pursuant to the authority vested in the Director under Neb.Rev.Stat. §§44-3601 through 44-3610.

- 03. For purposes of the insertion of relevant dates of adoption that are bracketed within the model, the Department has previously approved standards for "Pre-Standardized Medicare Supplement Benefit Plans," "Pre-Standardized Benefit Plan," and "Pre-Standardized plan" that were issued prior to June 1, 1992. It also previously approved the standards for "1990 Standardized Medicare supplement benefit plan," "1990 Standardized benefit plan" or "1990 plan" that were issued on or after June 1, 1992 but before June 1, 2010. This approval also included Medicare supplement insurance policies and certificates renewed on or after that date which are not replaced by the issuer at the request of the insured. The Department also approved standards for "2010 Standardized Medicare supplement benefit plan," "2010 Standardized benefit plan" or "2010 plan" for an effective date for coverage on or after June 1, 2010. Those standards remain in effect and are incorporated by reference in this regulation via the NAIC model.
- 04. In Section 8A(7)(c) of the model, the last sentence is amended to read "If suspension occurs and if the policyholder or certificate holder loses coverage under the group health plan, the policy shall automatically re-instituted (effective as of the date of loss of coverage) if the policyholder provides notice of loss of coverage within ninety (90) days after the date of the loss and pays the premium attributable to the period, effective as of the date of termination of entitlement."
- 05. In Section 8.1 of the model, the last sentence of the introductory paragraph is amended to read as follows: "Benefit standards applicable to Medicare supplement policies and certificates issued with an effective date for coverage prior to June 1, 2010 remain subject to the requirements of this regulation as it existed before June 1, 2010."
- 06. In Section 12B(1) of the model, the paragraph is amended to read as follows: "The individual is enrolled under an employee welfare plan that provides health benefits that supplement the benefits under Medicare; and the plan terminates, or the plan ceases to provide all such supplemental health benefits to the individual; or an individual is enrolled, due to current employment, under an employee welfare benefit plan that pays benefits secondary to Medicare, and the individual loses eligibility for coverage under the plan.
- 07. Additionally, when a policy or certificate is delivered by an agent, a receipt of delivery of the policy or certificate, shall be signed by the agent and applicant, at the time of delivery of the policy, if hand delivered. A copy of the delivery receipt will be provided to the applicant and a copy retained by the agent.
- 08. This regulation is effective immediately upon adoption by the Governor and publication by the Secretary of State.
