This matter came on for hearing on the 30th day of May 2012 before Eric Dunning, a hearing officer duly appointed by the Director of the Nebraska Department of Insurance. The Nebraska Department of Insurance ("Department") was represented by its attorney, Joel Green. Kennan Dozier Thomas, ("Respondent"), was not present and was not represented by an attorney. The proceedings were tape recorded by Tracy Gruhn, a licensed Notary Public. Evidence was received, and the matter was taken under advisement. As a result of the hearing, the hearing officer makes the following Findings of Fact, Conclusions of Law, and Recommended Order.

FINDINGS OF FACT

1. Respondent holds an expired insurance producer license. Her registered business address with the Department is 501 Plus Park Blvd., Nashville, TN, and registered home address is 14 Tradition Lane, Brentwood, TN 27027. (Exhibit 1).
2. The Department is the agency of the State of Nebraska charged with licensing insurance producers.

3. On or about April 18, 2012 the Petition and Notice of Hearing were served upon the Respondent by mailing the same to her registered business address, 301 Plus Park Blvd., Nashville, TN 37217 by certified mail return receipt requested, and home address 14 Tradition Lane, Brentwood, TN 27027 by First Class United States Mail. On or about April 30, 2012 the Domestic Return Receipt card attached to the certified letter was returned to the Department by the USPS confirming delivery. On or about May 8, 2012, the certified letter itself was returned to the Department of Insurance marked "Return to Sender –Unable to Forward." As of the date of the hearing, the Petition sent to Respondent's registered home address has not been returned to the Department by the United States Postal Service, and the Department has not received notice from United States Postal Service that the item was undeliverable. (Exhibit 2).

4. On February 15, 2012, Director of Insurance Bruce Ramage signed an Order in *State of Nebraska Department of Insurance vs. Kennan Dozier Thomas*, Cause No. A-1935, ordering Respondent to pay an administrative fine of \$1000 within thirty days of the adoption of the Order. On or about February 15, 2012, this Order was served upon the Respondent by mailing the same to her registered business address, 301 Plus Park Blvd., Nashville, TN 37217 by certified mail return receipt requested, and registered home address, 14 Tradition Lane, Brentwood, TN 27027 by First Class United States Mail. On or about February 24, 2012, the Domestic Return Receipt card attached to the certified letter was returned to the Department of Insurance by the United States Postal Service confirming delivery. On or about March 1, 2012, the certified letter itself was returned to the Department of Insurance marked "Return to Sender – Unable to Forward." As of the date of the Hearing, the Order mailed to Respondent by First Class United States Mail had not been returned to the Department by the United States Postal Service, nor

had the Department receive notice from the United States Postal Service indicating that the item was undeliverable. (Exhibit 2).

5. As of the date of the hearing, Respondent has not paid this administrative fine (Exhibit 1).

CONCLUSIONS OF LAW

1. The Department has jurisdiction and control over the licensing of Respondent to sell insurance in the State of Nebraska pursuant to Neb. Rev. Stat. §44-101.01 and §44-4001 et seq. Under Neb. Rev. Stat. §44-4059(5), the director retains authority to enforce the provisions of and impose any penalty or remedy authorized by the Insurance Producers Licensing Act even if the person's license or registration has lapsed by operation of law.

2. The Department has personal jurisdiction over Respondent.

3. Respondent violated Neb. Rev. Stat. § 44-4059 (1)(b) which states that the Director may impose a fine, suspend or revoke an agent's license if that person has violated "any insurance law or violat[ed] any rule, regulation, subpoena, or order of the director or of another state's insurance commissioner or director" as a result of the conduct set forth in Paragraphs 3 through 5 of the Findings of Fact.

DISCUSSION

Respondent's failure to abide by the terms of the previous Order of the Director of Insurance adds an additional violation to Respondent's previous failure to abide by the requirements placed upon licensed insurance producers by Nebraska law. Under Neb. Rev. Stat. §44-4059(5), the director retains authority to enforce the provisions of and impose any penalty or remedy authorized by the Insurance Producers Licensing Act even if the person's license or


registration has lapsed by operation of law. As Respondent continues to be subject to the terms of Nebraska law and has failed to comply with an Order of the Director, the Hearing Officer hereby recommends that Respondent's insurance producer license be placed on revoked status.

RECOMMENDED ORDER

Based on the Findings of Fact and Conclusions of Law, it is recommended that the Respondent's Nebraska insurance producer license be placed on revoked status. The Nebraska Department of Insurance shall retain jurisdiction of this matter for the purpose of enabling the Respondent or the Department of Insurance to make application for such further orders as may be necessary.
