In order to resolve this matter, the Nebraska Department of Insurance ("Department"), by and through its attorney, Michael C. Boyd and Jenifer Grendell, ("Respondent"), mutually stipulate and agree as follows:

JURISDICTION

1. The Department has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. §44-101.01 and §44-4047, et seq.
2. Respondent was licensed as an insurance agent under the laws of Nebraska at all times material hereto. Respondent's registered address with the Department of Insurance is 12550 W. Beam Hill Road, Denton, NE 68339.

STIPULATIONS OF FACT

1. The Department initiated this administrative proceeding by filing a petition styled State of Nebraska Department of Insurance vs. Jenifer Grendell on October 25, 2012. A copy of the petition was served upon the Respondent at the Respondent's address registered with the Department by certified mail, return receipt requested and by First Class U.S. Mail.

2. The petition alleges that Respondent violated Neb. Rev. Stat. § 44-4059(1)(h)

(Reissue 2010) as follows:

- a. During the course of an investigation into certain insurance related activities of Respondent and her spouse, James Grendell, the Nebraska Department of Insurance Consumer Affairs Division discovered that Respondent and her spouse had filed a Bankruptcy Petition #12-40199-TJM in the U.S. Bankruptcy Court District of Nebraska.
- b. In that Bankruptcy Petition, Respondent declares in Schedule E – Creditors Holding Unsecured Priority Claims that she and her spouse had failed to pay \$40,939.80 federal income taxes for the tax period ending 12/31/2008 and \$40,691.60 federal income taxes for the tax period ending 12/31/2009.

3. The petition further alleges that the Respondent violated Neb. Rev. Stat. §44-4059(1)(h) and §44-4059(1)(n) as follows:

- a. During the course of an investigation into certain insurance related activities of Respondent and her spouse, James Grendell, the Nebraska Department of Insurance Consumer Affairs Division discovered that Respondent and her spouse had filed a Bankruptcy Petition #12-40199-TJM in the U.S. Bankruptcy Court District of Nebraska.
- b. In that Bankruptcy Petition, Respondent declares in Schedule E – Creditors Holding Unsecured Priority Claims that she and her spouse had failed to pay \$8,000.00 Nebraska state income tax for tax periods 2008 and 2009.

4. Respondent was informed of her right to a public hearing. Respondent waives that right, and enters into this Consent Order freely and voluntarily. Respondent understands and acknowledges that by waiving her right to a public hearing, Respondent also waives her right to confrontation of witnesses, production of evidence, and judicial review.

5. Respondent admits the allegations set forth in Paragraphs #2 and #3 above.

CONCLUSIONS OF LAW

Respondent's conduct as alleged above in Paragraph #2 constitutes a violation of Neb. Rev. Stat. §44-4059(1)(h), and as alleged above in Paragraph #3 constitutes violations of Neb. Rev. Stat. §§ 44-4059(1)(h) and 44-4059(1)(n).

CONSENT ORDER

It is therefore ordered by the Director of Insurance and agreed by Respondent, Jenifer Grendell, that Respondent's insurance producer license shall be immediately revoked. Additionally, Respondent is required to return her license to the Department of Insurance within ten (10) business days from the date the Director of the Department of Insurance affixes his signature to this document and approves this consent agreement. In witness of their intention to be bound by this Consent Order, each party has executed this document by subscribing their signature below.


