JURISDICTION

1. The Department has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. §§ 44-101.01, and 44-4047 to 44-4067 (Reissue 2010).
2. Respondent was licensed as a resident insurance producer under the laws of Nebraska until his license was surrendered March 15, 2016.

STIPULATIONS OF FACT

1. The Department initiated this administrative proceeding by filing a Petition styled State of Nebraska Department of Insurance vs. Nathan Silva (NAIC National Producer Number 9079708), Cause Number A-2043 on August 8, 2016.
2. A copy of the Petition was served upon the Respondent at the Respondent's addresses registered with the Department by certified mail, return receipt requested, and by regular U.S. mail.
3. Respondent was informed of his right to a public hearing. Respondent waives that right, and enters into this Consent Order freely and voluntarily. Respondent understands


and acknowledges that by waiving his right to a public hearing, Respondent also waives his right to confrontation of witnesses, production of evidence, and judicial review.

4. Respondent neither admits nor denies the allegations stated in the Petition and Respondent agrees to this Consent Order only to resolve this matter in a timely fashion without the necessity of a hearing.

CONSENT ORDER

It is therefore ordered by the Director of Insurance and agreed by Respondent, Nathan Silva, that Respondent's previously surrendered insurance producer license shall be placed in a revoked status.


