In order to resolve this matter, the Nebraska Department of Insurance (“Department”), by and through its attorney, Krystle Ledvina Garcia, and Teddy Vandevort (“Respondent”), mutually stipulate and agree as follows:

JURISDICTION

1. The Department has jurisdiction over the subject matter and Respondent pursuant to Neb. Rev. Stat. §§ 44-101.01, and 44-2606 et seq. (Reissue 2010).
2. Respondent was licensed as an insurance consultant under the laws of Nebraska at all times material hereto.

STIPULATIONS OF FACT

1. The Department initiated this administrative proceeding by filing a petition styled State of Nebraska Department of Insurance vs. Teddy Vandevort (NAIC National Producer #5028698), Cause Number A-2088 on September 25, 2017. A copy of the petition was served upon the Respondent at Respondent’s registered business by certified mail, return receipt requested, and Respondent’s home address by certified mail, return receipt requested and by regular U.S. mail.

2. Respondent is alleged to have violated Neb. Rev. Stat. §§ 44-1525 (11), 44-2633(1), 44-2633(5), 44-2633(9), and 44-2633(10) (Reissue 2010) as follows:

- a. On or about February 27, 2015, Respondent was issued a Missouri resident public adjuster license.
- b. On or about April 3, 2015, the Department issued Respondent a Nebraska non-resident insurance consultant license based upon reciprocity.
- c. On or about February 27, 2017, Respondent's Missouri resident public adjuster license was placed on inactive status. Had Respondent not had an active public adjuster license at the time he applied for his license in Nebraska, the Department would not have issued Respondent a license.
- d. On or about June 27, 2017, Kevin Schlautman, Administrator for the Department's Licensing Division ("Schlautman") sent a written letter of inquiry to Respondent regarding his Missouri Resident Public Adjuster license. The letter was sent via Certified United States mail, return receipt requested, to Respondent's registered business address at 1503 N Washington, Chillicothe, MO 64601. On or about July 25, 2017, the letter was returned to the Department by the United States Postal Service as "Return to Sender-No mail Receptacle-Unable to Forward."
- e. On or about August 15, 2017, Schlautman sent another letter to Respondent regarding his Missouri Resident License. The letter was sent via Certified United States mail, return receipt requested to Respondent's registered residence address at 4902 Stonecrest Terrace, Saint Joseph, MO 64506. On or about August 23, 2017, the Department received the signed certified green card confirming delivery from the United States Postal Service.
- f. Respondent failed to respond to the letter dated August 15, 2017 within fifteen (15) working days.

3. Respondent was informed of his right to a public hearing. Respondent waives that right and enters into this Consent Order freely and voluntarily. Respondent understands and acknowledges that by waiving his right to a public hearing, Respondent also waives his right to confrontation of witnesses, production of evidence, and judicial review.

4. Respondent neither admits nor denies the allegations stated in Paragraph 2.

#### CONCLUSIONS OF LAW

Respondent's conduct as alleged above constitutes violations of Neb. Rev. Stat. §§ 44-1525(11), 44-2633(1), 44-2633(5), 44-2633(9), and 44-2633(10) (Reissue 2010).


CONSENT ORDER
